

Virginia Homeless Solutions FY15 Funding Awards

The Department of Housing and Community Development (DHCD) administers the Commonwealth of Virginia's homeless service resources through the Virginia Homeless Solutions Program (VHSP). These resources are used to reduce the number of individuals/households who become homeless; to shorten the length of time an individual/household is homeless; and to reduce the number of individuals/households that return to homelessness. Funds may be used for shelter operations, rapid re-housing, prevention, coordinated assessment, planning, Homeless Management Information System (HMIS), and administration. In addition, VHSP includes Housing Opportunities for Persons with AIDS (HOPWA) funds. These funds may be used for housing assistance and services that assist those with HIV/AIDS to maintain housing stability.
