Subject: Letter of Intent to Apply for Broadband Funding under the BEAD Program

Dear Virginia Office of Broadband Development Team,

On behalf of IBT Group USA, LLC, I am reaching out to declare our intent to submit applications for broadband funding under the BEAD program in the Commonwealth of Virginia.

IBT has been serving over 4,000 users for more than 10 years with a team of more than 50 fully qualified professionals with industry-specific experience in building, managing, and operating passive and active networks to deliver high-speed internet and related services, particularly in mission-critical environments that exceed the technical requirements of this endeavor. Most of our team's expertise comes from the Business to Business (B2B) world, where the service level requirement is higher and where we provide true 24/7 network and customer service and technical assistance to mission-critical businesses, including hospitals that demand high-quality service and security standards objectively measured through performance and management indicators. The team has extensive construction management experience, including deploying fiber-optic cabling, structured cabling, and installing active and passive equipment.

Over 10 years ago, IBT began offering internet connectivity and data transmission services, dedicated internet access services, point-to-point data links between customer sites, VPN links, extranets, and other IT services for sectors or industries related to healthcare, construction, and large commercial accounts. Leveraging this experience with high-quality performance standards and fiber optic deployment, IBT expanded into providing residential broadband services in Texas and Florida to provide the same high quality of services we deliver in the B2B world to individual residential households, primarily in unserved and underserved areas. We strategically partner with local governments, community organizations, and private stakeholders to ensure our projects are tailored to meet the specific needs of the communities we serve. These partnerships enable us to maximize resources, streamline implementation, and foster local economic development.

As an applicant for the BEAD Program in Virginia, IBT is committed to bringing this same level of expertise and innovation to the Commonwealth. Our proposed projects will prioritize unserved and underserved households and businesses while ensuring equitable access to community anchor institutions. With scalable designs, cutting-edge technology, and a focus on affordability, IBT is poised to bridge the digital divide and contribute meaningfully to Virginia's broadband goals.

We look forward to the opportunity to work with the Virginia Department of Housing and Community Development to expand broadband access and deliver transformative connectivity to communities in need.
