Dear Dr. Holmes:

Virginia Union University (VUU), as a not-for-profit community anchor institution (CAI), is formally expressing its intent to apply for the Virginia Department of Housing and Community Development's (DHCD) Broadband, Equity, Access, and Deployment (BEAD) Program. VUU seeks to establish a Public-Private Partnership (PPP), with letters of support from the City of Richmond and Xfinity (ISP), to enhance, expand, and improve broadband infrastructure. This effort aligns with Governor Glenn Youngkin's vision of universal broadband access, affordability, and adoption. Through this partnership, VUU is committed to advancing Virginia's mission of becoming a global leader in digital inclusion, with a particular focus on reaching unserved and underserved communities across the state.

From the DHCD's Office of Broadband published listing of 18,816 CAIs, identified in Virginia's BEAD Initial Proposal Volume 1, VUU shall focus on the CAI locations listed in Table #1 on supplemental page (2) of this document. The locations disclosed includes unserved sites below the gigabit symmetrical speed threshold physically on VUU's main campus.

To gain further insight into the BEAD program, application requirements, scoring criteria, narrative requirements, applicant certification documentation, and ZCTA submission portal preparation, VUU and its ISP partner will have representatives attend DHCD's two-day Application Development Workshop on December 3rd-4th, either on-site or virtually.
