2024 Balance of State Continuum of Care Funding Appeals Process

- Applicants will receive a summary of the priority ranking on October 8th , 2024.
- Applicants that wish to appeal the ranking committee's decision must notify the Department of Housing and Community Development's Homeless and Special Needs Program Manager (Darl Wilburn, <u>darl.wilburn@dhcd.virginia.gov</u>) in writing via email no later than close of business October 9th, 2024 with the following information
 - Agency name and contact information
 - Project name
 - Specific reason for appeal
- Applicant should note a clear explanation of the grievance with the grant application or decision-making process in their appeal.
- The Ranking Committee will review all appeals and make final decisions on Sept. 11th , 2024 via email vote.
- Applicants will be notified in writing of the appeal outcome not later than October 16th, 2024.
