



I. Introduction

Sixteen independent cities and counties form GO Virginia Region 5. The cities in GO Virginia Region 5 include Chesapeake, Franklin, Newport News, Norfolk, Hampton, Poquoson, Portsmouth, Suffolk, Virginia Beach, and Williamsburg. The counties include Accomack, Isle of Wight, James City, Northampton, Southampton, and York.

These localities comprise a dynamic metropolitan area with a rich history, a diverse landscape, and a population of more than 1.7 million people. The vibrant mix of people, places, and employment opportunities combine to make the region a popular destination for people to live, work, and play. As with any metropolitan region, there are many factors that influence the region’s quality of life, such as economic conditions, education, and the environment. The table below will provide a snapshot of the region’s target industry sectors. It should be noted that in May 2023 Life Sciences was added to the 2021 Economic Growth & Diversification Plan as a new industry cluster. Growth in this cluster over the last decade suggests that an opportunity exists to gain a significant competitive advantage. For more detail, please refer to the Economic Growth and Diversification Plan, updated in 2023.

Section III of the annual report will summarize the GO Virginia projects funded and launched between July 1, 2022 and June 30, 2023 that are tied to the goals, opportunities and industry sectors outlined in the 2021 Economic Growth and Diversification Plan.



Hampton Roads Executive Roundtable (the Roundtable), formerly Reinvent Hampton Roads, formed as a 501(c)(3) in 2016 and serves as the support organization for GO Virginia Region 5. The Roundtable combined Reinvent and the former Hampton Roads Business Roundtable in 1Q 2023 in order to re-align two regional organizations with similar missions and board overlap. The mission of the Roundtable and GO Virginia closely align as well – *to create more higher paying jobs through collaboration and innovation*. The Roundtable Board has thirty-one business, higher education, and organization CEOs and Presidents who geographically and ethnically represent the region. Currently, there are two members who serve on both the Roundtable Board and the Regional Council. Many of the Roundtable’s priority initiatives are directly connected to the GO Virginia program and to the Region’s Economic Growth and Diversification Plan.

This annual report is intended to capture GO Virginia activity and outcomes for the period from July 1, 2022, through June 30, 2023. Region 5, with the help of the Roundtable, applied for and received one Talent Pathways Initiative (PTI) grant totaling \$ 250,000; two GO Virginia Per Capita grants totaling \$ 5,248,977; and one Planning grants totaling \$ 100,000. These GO Virginia funds, leveraged with an additional \$ 15,723,170 in local and non-local match, brings the total investment to \$ 21,222,147, to support creating talent pathways focused on two priority industry clusters, elevating three economic development sites, creating a demonstration site for clean energy transition to green hydrogen, and producing a business plan for the Global Internet Hub along the I-64 corridor between Regions 4 & 5.

II. Economic Growth and Diversification Plan

Since the first Region 5 *2017 Economic Growth and Diversification Plan*, the six priority industry clusters identified have not changed, except for the addition of Clean Energy and Life Sciences. These priority clusters have been embraced by our region’s colleges and universities, partners in the entrepreneurial ecosystem, localities, and other regional organizations. GO Virginia funds have been used to expand the growth in each cluster, focused on making sure companies have the talent and resources they need to grow.

As the GO Virginia guiding document, the *Economic Growth & Diversification Plan* is embedded in the strategy and guides the initiatives of the Region 5 Council and multiple regional partners that are involved each time the plan is updated. An Executive Oversight Committee was created as part of the review of the 2023 Plan, comprised of leaders from the Hampton Roads Executive Roundtable and GO VA Region 5 Council. Other key groups actively engaged in the evaluation and implementation include the Regional Economic Development Directors (RED Team – the economic development directors from all localities in the region), and the diverse regional economic development organizations represented on the newly formed Regional Organizations Presidents Council (ROPC). Further, we intend to socialize throughout the region through various means of stakeholder engagement, such as social media and our new website, community forums, presentations at organization meetings, and other events.

Regional stakeholders are deeply involved in the process, and in the ongoing implementation of the Plan. Obtaining feedback from our local and regional partners remains a continuous process. For example, the Regional Council amended the 2021 Economic Growth & Diversification Plan in May 2023 to include Life Sciences as a priority cluster. The addition of this cluster came from our partnership in the Competitive GO Virginia grant awarded to support Virginia Bio Connect. Life Science is an emerging cluster in Region, 5 characterized by growing companies that include medical equipment and supplies manufacturing, scientific research and development services, and waste treatment and disposal, plus new entities such as the Hampton Roads Biomedical Research Consortium and the official merger of Old Dominion University (ODU) and Eastern Virginia Medical School (EVMS).

Another important part of the process has been our engagement with Old Dominion University. The ODU Dragas Center for Economic Analysis and Policy and the George Mason University Center for Regional Analysis were contracted by the Regional Council to produce the first Economic Growth & Diversification Plan in 2017. The Dragas Center was engaged to produce the biennial updates to follow. The relationship between the annual *State of the Hampton Roads Region Report* produced by the Dragas Center has been valuable as it informs work connected to the GO Virginia Region 5 Economic Growth & Diversification Plan.

III. Summary of Projects

While Region 5 was not the lead applicant for a Competitive Grant during this fiscal year, we were a partner in the *GO TEC Virginia 2025: A Multi-region Testbed for Innovation* project led by Region 3. The August 3rd Regional Council meeting was held at the *Brooks Crossing Innovation Lab* in Newport News. Members received a briefing and tour of the lab supported with this grant. The following projects led by Region 5 were funded in the last fiscal year:

Talent Pathways Initiative – The Hampton Roads Workforce Council (HRWC) is recognized statewide for its exemplary work in developing and managing talent pathways, as well as for inclusive industry, education, and advocacy partnerships here in Region 5, including the Bay Consortium on the Eastern Shore. The Regional Council selected HRWC to lead the Talent Pathways Initiative, given their success with a model applied in the maritime industry. This analysis is focused on *Cyber Security/Data Analytics/Modeling & Simulation* and *Uncrewed Systems & Aerospace*.

Several initiatives are underway that connect with these industry clusters. They include the Global Internet Hub (GIH) connection between GO Virginia Regions 4 & 5. Based upon analysis and comparison with 13 other internet hubs globally, this project makes the case for a regional cyber/data analytics/internet hub that will leverage an array of assets we have in the two regions, including data centers in Henrico County and the transatlantic subsea fiber-optic cables coming onshore in Virginia Beach.

The recent selection of Jefferson Lab by the U.S. Department of Energy for the nation’s new HPDF (High Performance Data Facility) will provide transformational capabilities for data analysis, networking, and storage for research enterprise. Similarly, the Hampton Roads Eastern Shore Autonomous Systems Strategic Playbook 2022/2023 funded through GO Virginia demonstrates the assets the region has for uncrewed systems and aerospace as a cluster, with R&D, air/land/sea/space testing sites, training, and education, plus companies such as DroneUp and Rocket Lab based in Region 5. Identifying needs and preparing the workforce will be critical to grow these sectors.

Hampton Roads Economic Development Sites Readiness Phase II – The Hampton Roads Planning District Commission (HRPDC), as the subgrantee was awarded a GO Virginia grant to complete due diligence work for three sites in Region 5 recommended by earlier studies, including the Enhanced Site Characterization project performed by the Virginia Economic Development Partnership (VEDP) in 2019. Leveraged with local resources, these funds were used to elevate Three Oaks Industrial Park (Chesapeake) and Southampton Commerce and Logistics Center (Southampton County) to Tier 4, and Beale Farm (Southampton County) to Tier 2. Each of these sites will attract new business development to the region, resulting in an estimated 400 new jobs and an estimated \$ 6.1 million in state income and tax revenue within 5 years of development.

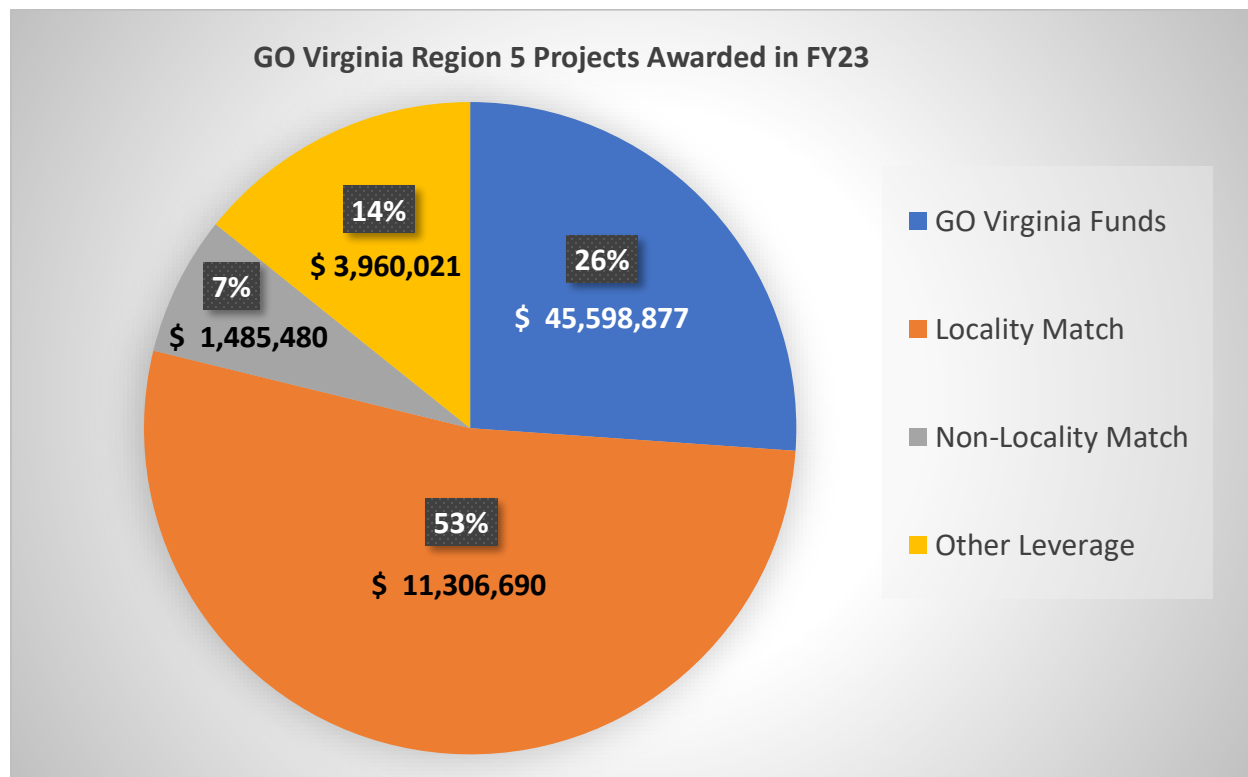
Demonstration Site for Clean Energy Transition to Green Hydrogen (HRH2) – Tech Center, LLC, a wholly owned subsidiary of the Virginia Tech Foundation, is leading the coalition to catalyze energy transition in Region 5 through a plan that leverages existing investments and regional competitive assets to: (1) initiate 3-5 green hydrogen transition projects to drive industry investments; (2) establish a hydrogen competency/demo center to educate and attract new business to Virginia; and, (3) create advanced workforce and talent programs to support the clean energy sector.

Region 5 has all the necessary ingredients to be a global contender for clean energy business, including green hydrogen. There is a regional demand for more resilient clean energy along with emerging availability of offshore wind (OSW) to produce storable, renewable energy in the form of hydrogen gas.

RVA757 Connects – In 2021, RVA757 Connects teamed up with GO Virginia Region 4 (Richmond) and 5 (Hampton Roads) to conduct the *I-64 Innovation Corridor Opportunity Study*, a research initiative to better understand the full potential of this collaborative work. One of the direct outcomes of this collaborative study was the identification of key target growth clusters and the digital infrastructure required to connect and support their growth. A plan with specific recommendations around creating a global internet hub will be delivered at the Convergence 2023 event held September 28, 2023.



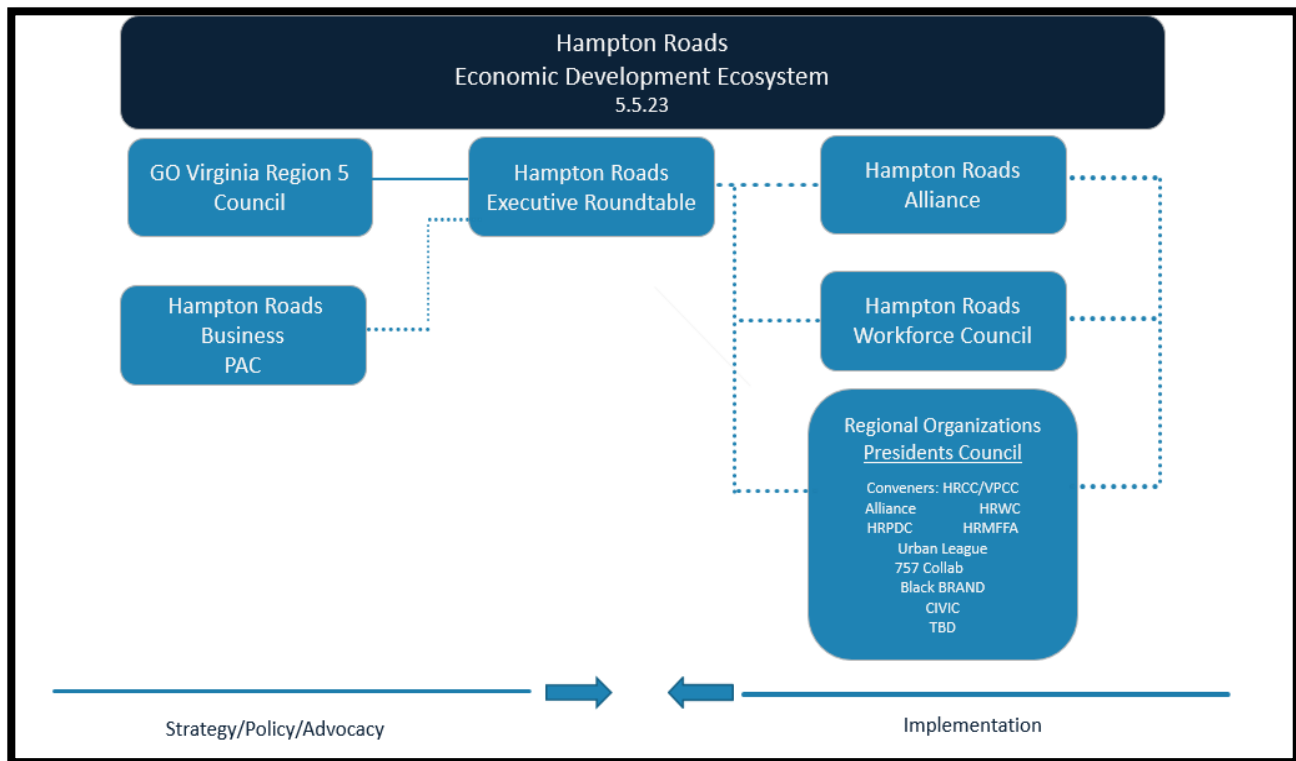
IV. Regional Collaboration & Partner Support

It is also important to note that the process to update the plan also included input from individuals based on specific topics requiring expertise (i.e., VEDP).

The graphic below of the *Hampton Roads Economic Development Ecosystem* shows the alignment of key regional organization with the Roundtable:



Over the last 6+ years, our region has developed a very collaborative approach to regional economic performance. The pace of this collaboration accelerated and took on an increased sense of urgency and importance during the pandemic a few years ago. The teamwork approach remains strong among regional agencies, non-profits, and educational institutions and encourages ownership of the Economic Growth and Diversification Plan.

V. Outcomes & Impact

Each quarter, the Region 5 Regional Council receives a summary update on all awards made since the GO Virginia program started. A copy of the report that was presented on August 3rd is attached for reference (**ATTACHMENT A**). It includes the outcomes/milestones achieved to date on each project, compared to the deliverables/products at the end of the grant, as listed in the executed agreement. The report also includes the GO Virginia funds drawn to date, to support each project. This report reflects progress made on each project through June 30, 2023.

It should be noted that the 757 COLLAB has far exceeded all outcomes/deliverables, beyond the grant closing date that was extended to December 31, 2023. The 757 COLLAB Impact Report 2022-2023 can be accessed [here](#).

VI. Communication and Outreach

A new website has been under construction since Reinvent Hampton Roads and the Hampton Roads Executive Roundtable merged into what is now the Hampton Roads Executive Roundtable. The website will launch in November 2023. In addition to the website the Roundtable will post GO Virginia news and information on social media platforms like Facebook and LinkedIn.

Photos of events/activities are included in ATTACHMENT D. Region 5 Council members and the Roundtable continually include background information, grant opportunities, and impact results as part of community event panels/speaking engagements and other communication. Council members routinely hear updates and outcomes from current sub-grantees, which in turn are shared across the community. Sub-grantees promote GO Virginia on their websites and materials, which further expands the outreach and impact of awards.

An important connection to highlight is one made with the Brookings Institute. Two of their programs are *Global Economy and Development* and *Brookings Metro*. Work that has been done through the GO Virginia program caught the attention of the leadership at Brookings. As a result, Nancy Grden, President & CEO of Hampton Roads Executive Roundtable, Shawn Avery, President & CEO of the Hampton Roads Workforce Council (HRWC), and Christina Brooks, Senior Director of Youth Services at HRWC were invited to be panelists at the [Brookings Metro Summit](#), sponsored by the Kresge Foundation scheduled in October 2023. Ms. Grden was asked to speak about the GO Virginia program and how it sparks, supports, and sustains regional economic initiatives. Mr. Avery and Ms. Brooks would speak about leveraging GO Virginia pathways investment to federal grants like the Good Jobs Challenge grant applied to the maritime industry cluster.

VII. Project Pipeline

The Regional Organizations Presidents Council (ROPC), in addition to the RED Team (local government Economic Development Directors coordinated through the Hampton Roads Alliance) meet regularly to solicit ideas to advance Region 5 priorities. Some ideas are developed, resulting in potential GO Virginia projects that are vetted and prioritized. Projects like *Hampton Roads Economic Development Sites Readiness Program Phase 2*, and the *Talent Pathways Initiative* went through this process.

GO Virginia grants awarded in Region 5 successfully lead to federal grant opportunities. One federal planning grant recently awarded to Jefferson LAB by the U.S. Department of Energy can be attributed to foundational work complete or currently underway, including investments made through the GO Virginia program.

Two situation analyses and strategic roadmap studies have further identified growth and innovation opportunities for our maritime/water-related industries, as well as for data sciences, which cuts across all of our key industry clusters. Both studies were prepared by TEconomy Partners, were sourced by the Hampton Roads Maritime Collaborative for Growth & Innovation, the Roundtable, and Old Dominion University, and have been instrumental in providing strategic direction for Region 5 GO Virginia projects.
