Dear Sir or Madam:

James Clifton Akers (the "Owner") is the fee simple owner of the Pine View Trailer Park located on that certain lot, tract or parcel of land situate at 3171 Eskeridge Road in the Town of Christiansburg, Montgomery County, Virginia (the "Property"). The Owner has received an offer for the purchase of the Property for the sum of Two Hundred Ninety Two Thousand and 00/100 Dollars (\$292,000.00) and, pursuant to VA Code Section 55.1-1308.2(B), has made such offer contingent upon the attached notice being provided in accordance with such code.

Closing will be conducted on, or subsequent to, sixty-one (61) days after this notice has been filed with the Department of Housing and Community Development.

As required by VA Code § 55.1-1308.2(B), during the sixty (60) day notice period, the park owner shall consider additional offers to purchase the park made by an entity that provides documentation that it represents at least 25 percent of the tenants with a valid lease in the manufactured home park at the time any such offer is made. Further, the attached notice has been provided to all Lot owners.
