Chapters 778 and 779 of the 2016 Virginia Acts of Assembly amended Title 2.2 of the Code of Virginia by adding Chapter 24 to create the Virginia Growth and Opportunity Board (the Board) and the Virginia Growth and Opportunity Fund (VGOF) within the Virginia Growth and Opportunity Act. Subsection 11 of §2.2-2486 of the code requires the Board to submit an annual executive summary of the interim activity of the Board by December 1 of each year. The information provided here provides an executive summary of the program and summarizes the activities of the Board from July 1, 2021 to June 30, 2022.

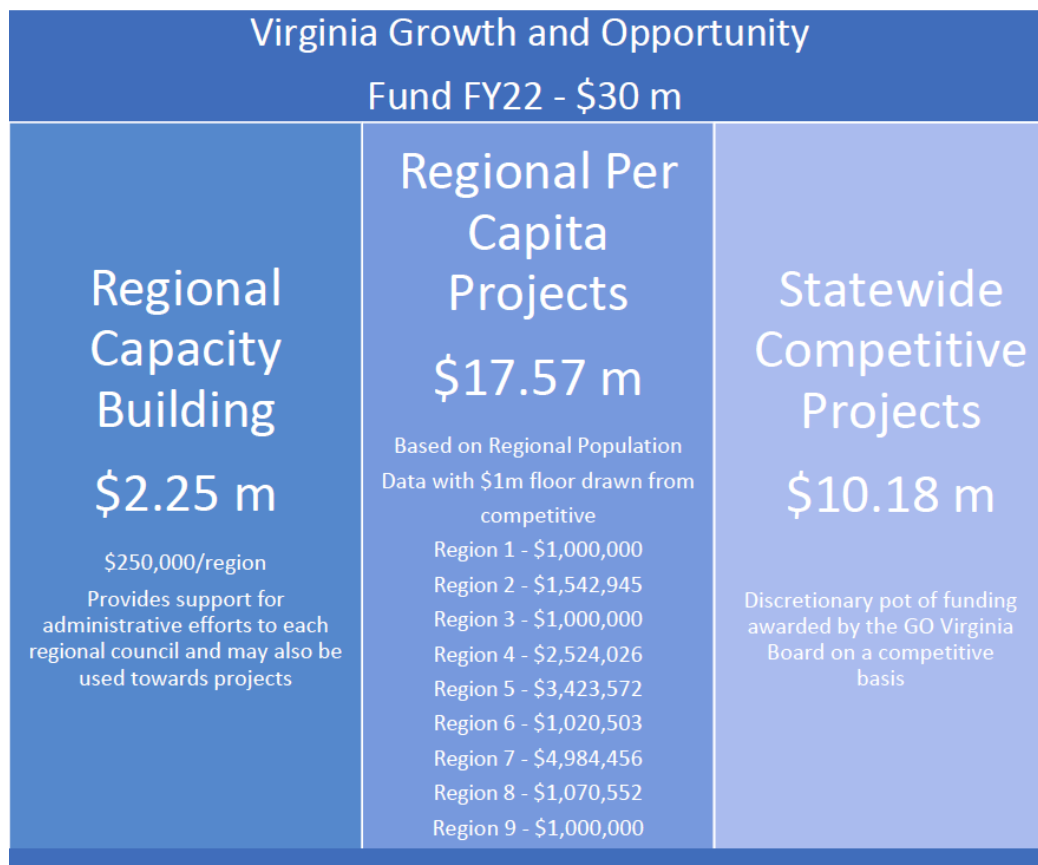

2 THE FUND

Appropriations for the Virginia Growth and Opportunity Fund are included in the budget for the Virginia Department of Housing and Community Development (DHCD). The fund, as created in §2.2-2487 of the Code, has three grant categories; (1) capacity building funds to assist regional councils in building capacity for job creation and program implementation (capacity building grants); (2) per capita project grants allocated to each region on a per capita basis for projects of regional significance (per capita grants); and (3) competitive grants awarded for projects of statewide economic impact and interregional collaborations (competitive grants).

The FY20-FY22 biennium budget allocated \$34.45 million for the fund in the first year and \$30.0 million for the second year. The following chart shows the distribution for FY22 among the three fund categories, including the per capita allocation across nine GO Virginia regions.



Following a year-end recapture and return of \$27.5M to the general fund, fiscal year end fund balances (Per Capita and Statewide Competitive Fund) available for future awards totaled \$17,430,520.

3 EXECUTIVE SUMMARY

The GO Virginia State Board continued its support of projects in four priority investment areas; startup ecosystem, cluster scale-up, workforce development, and site development and infrastructure. These strategies have been recognized as essential building blocks for sustaining and accelerating the growth of traded industry clusters, interrelated firms who together contribute significantly to Virginia's total economic output. Firms in supported traded cluster are positioned to compete to serve national and international markets and most importantly, drive wealth-creating employment opportunities for Virginians.

Program Impact Areas

Regional Collaboration

GO Virginia was developed to incentivize and reward regional collaboration that supports the growth and diversification of regional economies and more efficient use of state and local resources. **By measures, GO Virginia has helped to achieve these outcomes, engaging more than 200 unique public entities in collaborative regional economic development initiatives, including more than 150 units of local government (counties, cities, and towns), 15 regional economic development organizations/authorities, more than 30 school divisions, as well as planning districts and workforce development boards.**

GO Virginia was recently recognized by the International Economic Development Council for these efforts, receiving the highest honor Excellence in Economic Development Award for Regional Collaboration in 2022.

Leveraged Resources

Since program inception and through June 30, 2022, GO Virginia has awarded \$92.4 million in funding for 228 projects across the Commonwealth. In the spirit of regional collaboration, GO Virginia projects require the participation of two or more localities and matching funds from non-

state sources. **These project awards have leveraged more than \$109.4 million in additional funding from public and private sources.**

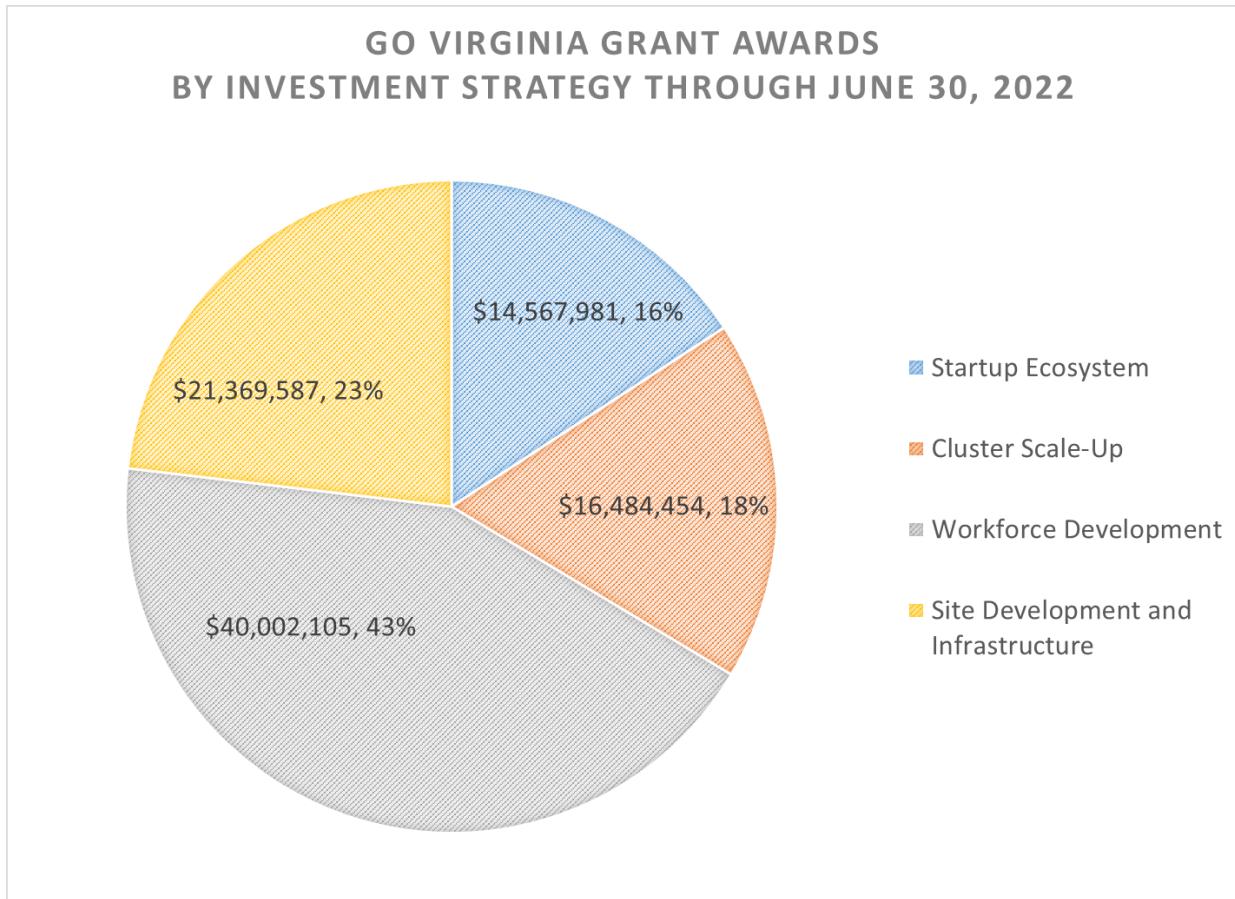
GO Virginia funded efforts have also demonstrated success in accessing federal funds. **During the most recent program year, more than \$77M in federal grants were awarded to projects inspired and funded by GO Virginia.** Notable in FY 2022, project leads in GO Virginia regions Four and Five were successful with two of the US Economic Development Administration's most competitive programs – the Build Back Better Regional Jobs Challenge and the Good Jobs Challenge. Collectively, they attracted \$64M in federal funds to support efforts to establish an end-to-end supply chain for the emerging advanced pharmaceutical manufacturing cluster in Region 4 and to expand the pool of qualified workers to support the blue economy and clean energy industries and address critical shortages in cybersecurity roles in Region Five.

High-Impact Outcomes

Through June 30, 2022, GO Virginia projects under contract have pledged to support the following outcomes during their grant performance period.

- Create 26,000 new jobs
- Train 13,000 students in high demand fields
- Create 2,700 new work-based learning opportunities, including internships and apprenticeships
- Award 3,600 workforce credentials
- Serve 14,000 existing businesses
- Create 800 new businesses in traded sector industries
- Prepare 10,000 acres for future economic development opportunities

The following chart shows the distribution of GO Virginia funds across these focused investment areas since program inception.

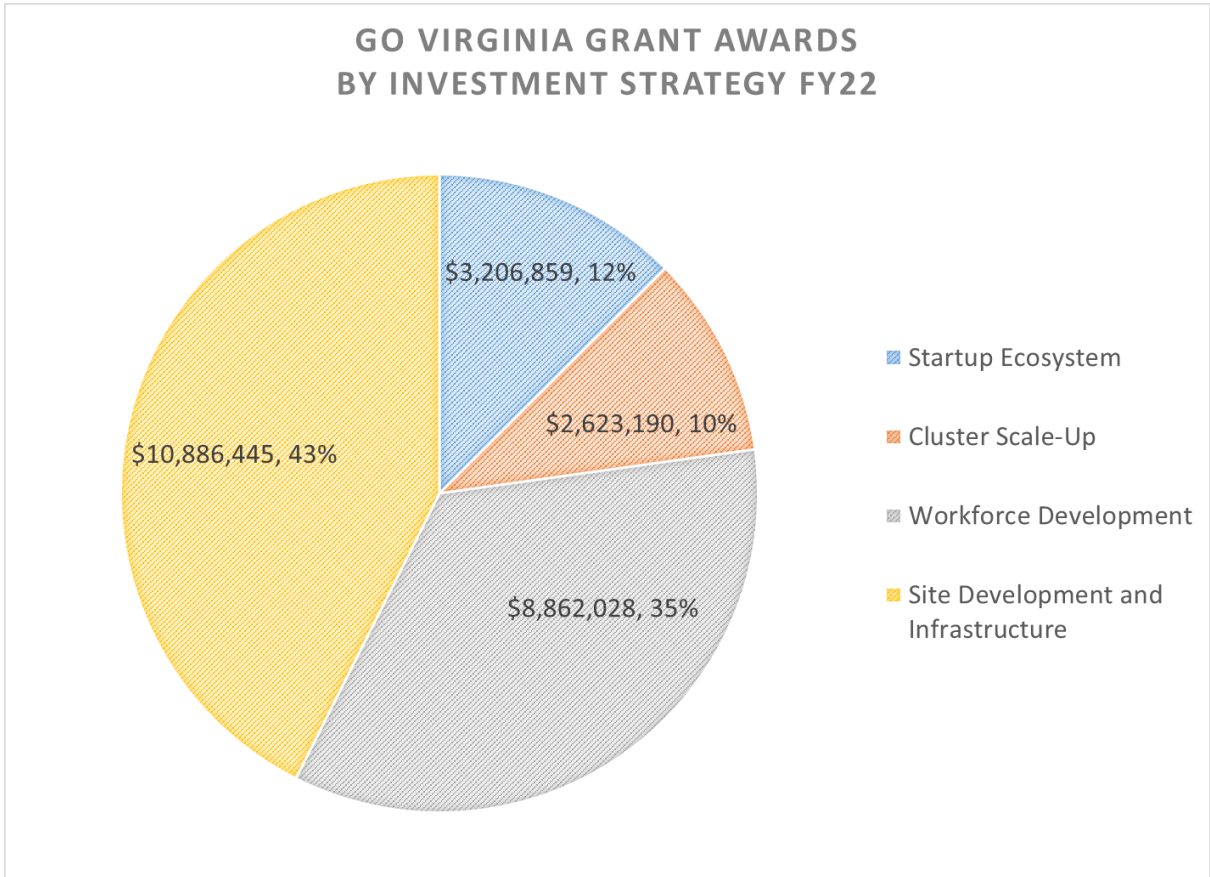


4 THE VIRGINIA GROWTH AND OPPORTUNITY BOARD

The Virginia Growth and Opportunity Board consists of seven legislators, three ex-officio members with voting privileges from the Governor's Cabinet, and fourteen private sector representatives. A full list of board members seated on June 30, 2022 can be found in [Appendix A](#).

The GO Virginia State Board held five meetings during the fiscal year. The deliberations and actions are described in detail in Section 5 of this report. The Board awarded \$25,578,522 in support of 45 collaborative economic development projects across the Commonwealth. These initiatives leveraged more than \$28M in qualifying non-state investments.

The following chart shows the award distribution by investment strategy for FY22. Forty-three percent of the total awards supported site development and infrastructure. Notable investment included a \$5.0M award from the Statewide Competitive fund in which GO Virginia Region 3 led an application with Region 4 as a partner which will extend critical middle mile broadband infrastructure to a series of industrial parks.



4.1 KEY BOARD ACTIONS AND ACTIVITY

The following section describes the key actions and determinations of the Board. Details regarding the agendas, meeting materials, and meeting minutes can be found under the provided links.

Board Meeting - September 23, 2021

The Board elected Nancy Agee to serve as Chair and Todd Stottlemeyer to serve as Vice Chair for a term of one year. The Board also amended [Policy #12 Use of Tobacco Commission Funds](#)

[as Match](#), which extended the ability of select regions to use Tobacco Commission funds to meet 50% of the required project match through June 30, 2022.

They also approved an amendment to [Policy #9 Use of GO Virginia Funds for Site Development Investments](#). This change gave DHCD the authority to consider post-award amendments to sites applications involving multiple sites assuming the award amount was unaffected and that any changes to sites qualified under the approved program guidelines.

The Board considered ten applications, which included eight regional Per Capita Applications and two requests under the Economic Resilience and Recovery Initiative. The Board approved seven and deferred three of these projects.

The Board considered ten applications, which included nine regional per Capita Applications and one Economic Recovery and Resilience application. Final Board actions during this round included to deny funding for one project, one project deferral, and eight approvals.

Special Board Meeting - March 10, 2022

The Board held a special meeting on March 10th to take action on two time sensitive applications. The meeting was called by members Leah Fremouw and Jim Dyke citing the need to act in advance of critical application deadlines presented by the US Economic Development Administration.

New members joining included Secretary Caren Merrick, Secretary Steve Cummings, Speaker of House, Todd Gilbert, Delegate Barry Knight, Chairman of the House Committee on Appropriations and Delegates Terry Kilgore and Terry Austin.

The Board considered an application from Region 4 - Building a Pharmaceutical Manufacturing Talent Pipeline (\$482,330). This project will result in the development of two new pharmaceutical manufacturing technician-training programs to meet the needs of the emerging industry cluster.

The second application considered was a \$5 million Statewide Competitive application lead by Region 3 in partnership with Region 4. The project will allow Mid Atlantic Broadband to construct six middle-mile broadband segments that will connect industrial parks and employment hubs in these regions and support the expansion of firms in the regions' shared industry targets.

Both application were approved.

Board Retreat – April 20-21, 2022

The Board held a retreat in Richmond on April 20-21. The purpose of the meeting was to orient new members to the GO Virginia program framework, review the achievements of the program since inception, present best practices and exemplary projects, and engage in a discussion about future focus for the GO Virginia program. No actions were taken during the retreat. A full business meeting followed.

The Board approved the Growth and Diversification plans submitted by the nine GO Virginia Regional Councils. These plan reviews are conducted each year as required by State Code and serve as strategic actions plans for project development and future investments. Each plan identifies the priority industry targets for each region as well as the goals and economic development strategies they will pursue to accomplish them. The following chart illustrates the priority industry sector selected by each region.

The Board certified the nine Regional Councils as required by State Code. They certify annually that the regional council member selection process, membership, governance, structure, composition, and leadership meet the requirements of this article and the program guidelines and procedures. Further, the certification process ensures that the regional council has adopted bylaws and taken other such steps in its organizational activities and business plan as are necessary or required by Board guidelines and procedures to provide for accountability for and oversight of regional activities funded from the Fund.

The Board also took actions to extend [Policy #11 GO Virginia Program Match Per Capita Requests](#) through June 20, 2023 and adopted [Policy #13 GO Virginia Program Match Requirement - Statewide Competitive Projects](#). Each of these policies defined modified match

requirements under the Board's authority to reduce the match requirement to no less than half of the grant upon a finding by the Board of fiscal distress or an exceptional economic opportunity in a region.

Board Meeting - June 14, 2022

The Board convened in June and approved the distribution of the FY23 program fund using the methodology described in the budget.

Following the legislative session, the Board also amended Policy #12, continuing the allowance for Tobacco Commission funds to be used for 50% of the match required by GO Virginia projects.

The Board considered fifteen applications that included 10 regional Per Capita applications and five Economic Resilience and Recovery initiative applications.

The Board also approved a methodology to accommodate the reversion of \$27.5M from the GO Virginia fund to the state general funding following the signing of the budget by the Governor. The recapture impacted eight GO Virginia regions as well as the Statewide Competitive Fund and was determined at fiscal year-end as the total unobligated regional fund balances for resources appropriated in FY19, FY20 and FY21. To fully accommodate the application requests presented, a portion of the FY22 Statewide Competitive fund was impacted.

5 FY22 GRANT AWARDS

To support the GO Virginia program goals and objectives, as well as the pandemic response, the GO Virginia State Board approved \$25.6 million in funding for 45 projects during FY22. These grants attracted an additional \$28.6 million in matching funds from private and public sources.

5.1 REGION ONE

Region One includes the counties of Bland, Buchanan, Carroll, Dickenson, Grayson, Lee, Russell, Scott, Smyth, Tazewell, Washington, Wise and Wythe; and the cities of Bristol, Galax, and

Norton. In FY21, Moir Beamer led the Region One Council as chair and Beth Rhinehart served as vice chair. The University of Virginia at Wise served as the support organization for the Region One Council.

The Region Two Council is led by Raymond Smoot as chair and Ab Boxley as vice chair. Virginia Tech's Center for Economic and Community Engagement serves as the support organization for the GO Virginia Region 2 Council.

The Region Three Council is led by Randy Lail as chair and Charlie Majors as vice chair. The Southside Planning District Commission (SPDC) serves as the support organization, in partnership with the University of Virginia’s Weldon Cooper Center for Public Service.

The Region Four Council is led by Mark Hourigan as chair, Todd Haymore as vice chair and is supported by the Grow Capital Jobs Foundation, a nonprofit established to support regional economic development efforts.

5.6 REGION SIX

GO Virginia Region Six includes the counties of Caroline, Essex, Gloucester, King and Queen, King George, King William, Lancaster, Mathews, Middlesex, Northumberland, Richmond, Spotsylvania, Stafford and Westmoreland; and the city of Fredericksburg.
