AMENDMENT TO THE VIRGINIA DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT - NATIONAL DISASTER RECOVERY GRANT AGREEMENT

THIS AMENDMENT TO THE VIRGINIA DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT – NATIONAL DISASTER RECOVERY GRANT AGREEMENT ("Amendment") is entered into this First day of July, 2021, by and between the Virginia Department of Housing and Community Development which is the COMMONWEALTH OF VIRGINIA PASS-THROUGH ENTITY RECIPIENT, therein referred to as "RECIPIENT", and the Nonprofit COASTAL COMMUNITY RESILIENCE, INC. DBA RISE therein referred to as "SUBRECIPIENT."

RECITALS

WHEREAS, the Commonwealth of Virginia has been authorized to distribute and administer Community Development Block Grant (CDBG) funds pursuant to the Housing and Community Development Act of 1974, as amended, and

WHEREAS, the RECIPIENT has been authorized by the Governor of the Commonwealth of Virginia to distribute and administer to the SUBRECIPIENT the B-13-DS-51-0001 CDBG-DR SUBAWARD, with the Catalog of Federal Domestic Assistance (CFDA) number 14.272, which was awarded to the Commonwealth of Virginia as a successful applicant to the National Disaster Resilience Competition (NDRC), and

WHEREAS, the RECIPIENT and SUBRECIPIENT entered into an Agreement dated May 24, 2017 (the "Agreement") to administer the National Disaster Recovery Grant #16-NDR-02 Nonprofit COASTAL COMMUNITY RESILIENCE, INC., DBA RISE Grant Agreement, and

WHEREAS the original Agreement specified a PERIOD OF PERFORMANCE requiring the SUBRECIPIENT to complete the work as described in the Agreement on or before June 30, 2022, and

WHEREAS, on December 27, 2020, both houses of the One Hundred Sixteenth Congress enacted the Consolidated Appropriations Act, 2021, which in part provides a selected group of grantees, including the Commonwealth of Virginia, with one additional year for the expenditure of Community Development Block Grant disaster recovery (CDBG-DR) funds,

NOW, THEREFORE, the RECIPIENT and SUBRECIPIENT hereby agree to amend the NDR Grant Agreement as follows:

1. By deleting the first sentence of section 7 and replacing it with the following: PERIOD OF PERFORMANCE - The SUBRECIPIENT shall complete the work as described in the GRANT AGREEMENT within 6 years, 1 month, 6 days (excluding the end date) of the execution of the original Agreement, or more specifically on or before June 30, 2023.

Except as modified hereby, the terms of the Agreement shall remain in full force and effect.
